2022 CANDIDATE SURVEY QUESTIONS | FULL TEXT

- 1. ASSISTANCE TO THE POOR. Funding in Maryland's budget should be maintained, and when necessary, increased to provide low-income residents access to basic necessities, such as food, housing, and healthcare.
- 2. ABORTION. Maryland is one of very few states that voluntarily direct state Medicaid funds to pay for all or most medically necessary abortions, which includes abortions performed to protect the mental health of the mother. The Maryland General Assembly should pass legislation to restrict the use of taxpayer dollars for abortion.
- **3.** ENVIRONMENT. The State of Maryland should support initiatives such as tax credits or grant programs to encourage Maryland residents, businesses and non-profits to reduce their carbon footprint.
- 4. K-12 EDUCATIONAL OPTIONS. The State of Maryland should continue to expand existing funding to provide scholarships for low-income students who wish to attend the K-12 nonpublic school best suited for their educational needs.
- 5. PHYSICIAN-ASSISTED SUICIDE BAN. In 1999, the Maryland General Assembly passed legislation making it a felony for an individual to assist in another individual's suicide. Maryland should uphold the law in its current form and reject legislation to legalize the practice of physician-assisted suicide.
